1 GENERAL CHARACTERISTICS

- **1.1** The supplier guarantees that the laminate and its components meet the requirements of the current laws governing materials in contact with foods (Ministerial Decree of 21.03.73 and subsequent amendments and updates, EEC Directives).
- **1.2** The laminate must be free of nasty odours.

2 AESTHETICAL CHARACTERISTICS OF THE CUSTOMIZED PRODUCTS

2.1 Printing must be done according to the graphic files sent by the customer, who takes responsibility for checking the wording, graphics and layout.

3 STRUCTURAL CHARACTERISTICS OF THE REELS

- **3.1** The reels must be rolled tightly enough to prevent deformation during transport and handling.
- **3.2** Raised areas on the surface could be seen due to the overlapping of the layers.
- **3.3** The winding direction must be as indicated on the technical drawing.
- **3.4** The lateral surfaces of the reels must be flush; a tolerance of 2 mm is accepted.
- **3.5** The printing must be centered with a tolerance of 2 mm from the ertical slitting line.

3.6 Splicing must:

Be made with a specific splicing tape Have a colour in contrast with the printing background Be adequately signed on the sides of the reels with visible tags

3.7 The outer diameter of the reels must be as indicated on the customer order.

A tolerance of + 0 / - 10 % on the indicated value is acceptable. On the whole consignment, some reels with a diameter less than the required are accepted (production tails). Their number depends on the batch size.

3.8 The internal diameter must be as indicated on the order with a tolerance of - 1 / + 2.5 mm; the core must be strong enough to prevent problems occurring during the production process.

4 PACKAGING

- **4.1** The reels must be packed to be satisfactorily protected from weather changes, dirt and dust.
- **4.2** Every reel must bear two labels, one outside and one inside the core. These will give:

5 DELIVERY, STORAGE AND USAGE CONDITIONS

5.1 TRASPORTATION

The transport is organized in the cleanest and best technical conditions to preserve the bags at their best. Transportation is done in covered lorries. Upon arrival if any damaged good is noticed, it must be registered in written on the packaging list and duly signed by the vehicle driver, without this no claim procedure can be started and therefore no compensation can be given for the damaged goods.

5.2 STORAGE

The storage facilities must be in the cleanest and best technical conditions to ensure a good preservation of the goods. The bags must be kept in their original wrappings in the warehouse, at a temperature between 10°C and 30°C with relative humidity between 50% and 70%. Avoid direct exposure to sunlight and sources of heat. Storage in conditions other than those indicated above may alter the characteristics of the material. A period of acclimatization in the production department for at least 48 hours before use in recommended.

6 COMPLAINTS

In case of complaint the customer must return to the supplier the "Label" of the claimed reel together with representative samples of the defect. Without this no claim procedure can be started and therefore no compensation can be given for the damaged goods.
